Description

The VARIANT*Plex*-HT AML Focus panel is a balanced pool of gene-specific primer (GSP) oligonucleotides that is optimized for use with VARIANT*Plex*-HT reagents and molecular barcode (MBC) adapters to produce targeted NGS libraries. This product insert should be used in conjunction with VARIANT*Plex*-HT protocol for Illumina® (RA-DOC-058).

VARIANT*Plex*-HT AML Focus contains **226** GSPs targeting **11** genes commonly mutated in Acute Myeloid Leukemia.

Recommended reads and multiplexing

VARIANTPl_{ex}-HT AML Focus libraries should be sequenced to a minimum of **800,000** reads. Starting read depth recommendations for standard profiling may be adjusted based on user needs.

Archer™ Analysis settings

Sequencing data should be processed using Archer Analysis (v7.0, or greater). The VARIANTPl_{ex}-HT AML Focus panel requires selection of the **SNV/Indel and Structural variation** pipelines, found under the **DNA** Input Type (see the Archer Analysis User Guide for more details on setting up your analysis). Selection of the DNA Target Coverage pipeline is optional.

Processing of VARIANTPl_{ex}-HT AML Focus libraries requires a one-time upload of the Panel GTF. When performing DNA Target Coverage analysis, users must also select a Region of

Interest BED file. Users may optionally add a Targeted Mutations VCF file for targeted SNV/Indel detection. Files can be obtained by contacting archer-tech@idtdna.com
